

## Privacy Policy

The purpose of this Privacy Policy (hereinafter referred as **“Policy”**) is to inform you as to what information may be collected by MetaHash AG, registered address at Gartenshtrasse 6, 6300 Zug, Switzerland (hereinafter referred as **“the Company”, “we”, “us”, “our”**) from you when you visit and use our Website <http://metahash.org/> (hereinafter referred as **“this Website”** or **“our Website”**) and/or Applications, downloaded from our Website, how such information will be used by us, with whom such information may be shared, your choices regarding the collection, use, and distribution of such information, your ability to edit, update, correct, or delete such information and the security procedures that we have implemented to protect your privacy.

The application of this Policy does not depend on whether you use the Website or Applications downloaded from Website, this Policy applies in any case.

This English version of this Policy is the Official version. If you do not speak English, you can use translation services or translated versions of this Policy available on our Website. However, please, note that in case of any discrepancies the English version shall always prevail.

### Collection of Information

On various occasions you may be asked for certain types of personally identifiable information, such as:

- your first and last name;
- username, password;
- citizenship;
- phone number;
- e-mail address;
- cryptocurrency wallet address;
- other personal information you choose to provide;
- other personal information we obliged to obtain from you in accordance with our AML Policy.

We hope that you will provide us with this information. However, if you do not want to disclose your personally identifiable information to us, please do not submit it. This means that in some cases we will not be able to provide you the service you have requested. By submitting your personal information on our Website you agree and give your consent to us for collecting, processing, using, storing and disclosing your personally identifiable information.

We may also collect non-personally identifiable information from you when you visit the Website (e.g. IP address, browser type, domain name, the date and time of visits, the pages viewed, time spent at our Website etc.). This information is collected and analyzed in the aggregate in order to improve the functioning and content of the Website.

You may be asked to provide some information to third parties, namely, to our partners who communicate with us under certain agreements. Such information may be requested by third parties for the purpose of your communication with us. Terms of this Policy are accordingly applied to processing your personal data by third parties and your communication with third parties. Personal data provided to third parties might be collected, stored and used by such third parties.

Please, be informed that indicated personally identifiable information may be collected both on our Website and in the Applications that you download from our Website. We may expand the list of personally identifiable information requested from you by amending this Policy.

## Use of Information

We use information provided by you for a variety of purposes. You will be informed as to these purposes at the time the information is collected. In general, however, we foresee the following purposes:

- provide you with the access to digital assets;
- provide you with the access to experimental technology and software;
- understand and meet your needs and preferences;
- develop new and enhance existing service and product offerings;
- manage and develop our business and operations;
- carry out any purposes for which we have received your consent;
- monitoring and analyzing trends, usage and activities in connection with our Website;
- marketing purposes (add you to our email subscription list, send you promotional materials, etc.);
- matching your Information with job vacancies to assist us in finding a position that is most suitable for you if you have contacted us about recruitment;
- meet legal and regulatory requirements.

Non-personally identifiable information may be used to analyze trends and statistics, enhance the Website's operation, and serve content and advertisements.

## Processing

We will process your personal data legally and fairly and not use it outside the purposes of which we have informed you. So far as we are able we shall ensure that all of your personal data is accurate and up to date.

## Storage of personal data

Data provided to us is stored in accordance with applicable laws of the jurisdiction of the data subject, at secure locations. We take reasonable steps to ensure that the personal information we collect about you remains accurate, timely, and secure. You shall understand that your personal data might be processed and stored by our counterparties who provide us with services for processing and storing your personal data in various geo (jurisdictions of data subject). All such third parties will be contractually bound to protect data in compliance with our Policy.

Unfortunately, no data transmission over the Internet can be guaranteed to be 100% secure and while we strive to protect your personal information, we cannot guarantee or warrant its complete security. We shall not be responsible for losses that you or any person may suffer as a result of a breach of confidentiality in respect to your use of the Website or any information you transmit to the Website. Also, we do not assume any responsibility for the data you submit to or receive from us through the Internet or for any unauthorized access or use of that information and we cannot and do not guarantee that information communicated by you to us or sent to you by us will be received or that it will not be altered before or after its transmission to us.

We will only share your personal data in the following ways:

- analytics and search engine providers that assist us in the improvement and optimisation of our Website;

We may disclose information that we collect about you should we have reason to believe that:

- it is necessary to identify, contact, or bring legal action against persons or entities who may be causing harm to you, us, or others;
- it is necessary because of official inquiry of governmental authorities;
- it is necessary securing compliance with law's provision or with requirements of judicial proceedings concerning us;
- we may also disclose information when we believe the law requires it.

## Access or corrections to your information

You are able to correct, update or change your personal data provided to us. You can correct, update or change your personally identifiable information by sending us an e-mail or make it by yourself in your personal account if our Website gives you such opportunity.

In addition, you may request us to delete your personally identifiable information from our database. Upon your e-mail request to terminate the processing of your personally identifiable information, we will terminate processing your personal data. Our contact information is listed below. We will use commercially reasonable efforts to accommodate all such requests. Please, note that we cannot delete the transactions information from Blockchain.

You may also opt out of receiving promotional communications from us at any time by following the instructions in those communications.
